### **Qualifications for Entry:**

- Entrants must be amateur composers age 18 and over. MFMC membership is not required.
- Compositions must be non-published, original works.
- Compositions may be single pieces, or a group of related pieces (e.g. sonata, suite).
- Composers may submit one composition per person per year.
- A work may be submitted only once, not year after year.
- A composition may be hand written or computer generated; a photocopy of the composition may be submitted so the composer may retain the original.
- A cassette tape recording or cd of the composition is required.

### **Critique:**

The critique will cover originality and correctness of melody, harmony, rhythm, form, musicianship, accuracy and neatness.

### **To participate, please enclose the following items:**

- 1) Completed application form.
- 2) One copy of your original composition, unfolded in a large envelope.
- 3) CD or cassette tape recording of your composition.
- 4) Self-addressed, stamped large envelope for the return of your work and the critique.
- 5) A check in the amount of \$25.00 for the first 2 pages of the composition, plus \$5.00 for each additional page, made payable to MFMC Adult Composer Critique.
